

• I will share and combine my talents and passions to create a place where problems are solved and our community is improved in a sustainable manner.



# IVGID Sustainability Framework



### Summary of Initiatives and Goals

- Resolution #1836 Environmental Sustainability Res. (4/29/2015)
  - Recognizes environmental sustainability as an essential behavior of IVGID
  - Defines a need to evaluate sustainability topics for economic and environmental benefit to the District
- Long Range Goal #1 Resources and Environment Doc.
  - Includes new language on sustainability measures and goals
  - Creates objectives to form a sustainability committee and to produce a policy to purchase environmentally preferable products
- Sustainable Procurement and Waste Reduction Initiative
- Climate and Drought Resiliency Initiative and Action Plan

# IVGID Sustainable Procurement and Waste Reduction Initiative

- Separate policy to mandate purchasing policy to favor sustainable or recycled products
- This policy should also mandate "Waste Not" re-use, reduce and recycle for all employees and all departments
- This is based on Washoe County's sustainable purchasing policy
  - City of Reno uses the exact same policy
- Based on NRS 332.065 and NRS 444A.020

### Sustainability Committee

- Administered by the IVGID Public Works Waste Not Program
- Lead role by Sustainability Intern
- Members from IVGID departments and venues as well as leadership committee and community advisory committees.
- Discuss sustainability measures, objectives and projects to complete in order to be consistent with sustainable communities' goals.
- Meet monthly

Develop Sustainability strategies for these venues/departments

- Stage 1 Develop a Sustainability Strategy
- Stage 2 Focus Inward

Strategy elements in sustainability include but are not limited to: Economic Health, Community Health and Safety, Greenhouse Gas

Emissions Reduction, Forest and Biological Health, Recreation, Hazard Mitigation, Energy, Solid Waste and Recycling, Water and Air Quality

# IVGID Sustainability Strategy



### Implementation

July - December	January - March	April - June
Stage One – Develop a Sustainability Strategy	Stage Two – Focus Inward	Stage Three – Focus Outward

The timeline for the sustainability strategy will repeat itself every year as it tracks progress and maintenance of the management system.

A yearly progress report will be developed by January 1<sup>st</sup> of each year to help inform managers during the next budget cycle process.

#### Education and Outreach

- Community Engagement
  - Contribute to the rising transparency regarding sustainability in the region
  - Sustainability Action Plans may become a requirement in Lake Tahoe
- Staff Training
  - Train all staff regarding information on best management practices
- Recognition
  - There is a developing myriad of certification programs that measure and classify venues and services on sustainability performance
